As HTHK is owned by HSBC International Trustee Limited ("HKIT"), HKIT is thus deemed to have an indirect interest in the shares. As a result of a transfer by HSBC Bank Bermuda Limited of all its shares in HKIT to HSBC Private Banking Holdings (Suisse) SA ("HPBH"), HSBC Bank plc is now deemed to be a substantial shareholder of the Company. HPBH is a wholly-owned subsidiary of HSBC Europe (Netherlands) BV, which is substantially owned (94.9%) by HSBC Bank plc which is a wholly-owned subsidiary of HSBC Holdings plc. 4.
