San Miguel Foods Asia Limited, prior to the transfer of its shares in NutriAsia San Miguel Holdings Ltd to Well Grounded Limited, owned 42.2% of NutriAsia San Miguel Holdings Ltd, which in turn owns 100% of NutriAsia Pacific Ltd ("NPL"), which in turn owns 84.52% of Del Monte Pacific Limited. Prior to the transfer of its shares in NutriAsia San Miguel Holdings Ltd to Well Grounded Limited, San Miguel Foods Asia Limited was therefore deemed to be interested in the 914,357,372 shares in Del Monte Pacific Limited held by NPL.
